Agreement between User and txcivilrights.org

Welcome to txcivilrights.org. The txcivilrights.org website (the "Site") is comprised of various web pages operated by Texas Civil Rights Project ("TCRP"). txcivilrights.org is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of txcivilrights.org constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

txcivilrights.org is a Non-Profit Site.
